is hereby authorized to purchase beverage alcohol from the Saskatchewan Liquor & Gaming Authority (SLGA) and to sell that beverage alcohol in accordance with the provisions of *The Alcohol and Gaming Regulation Act, 1997*, and *The Alcohol Control Regulations, 2016*, and all conditions prescribed by SLGA during the maximum time and in the areas described below:

MAXIMUM HOURS OF SERVICE

- Daily – Maximum hours of sale, service and consumption 9:30 am to 2:00 am (tolerance to 3:00 am)
- Dec 31st – Maximum hours of sale, service and consumption 9:30 am to 2:30 am (tolerance to 3:30 am)

PERMIT CONDITIONS

- Beer of a type and size specified by SLGA sold for consumption on premises must be recorked on request of the customer.
- If wine is sold by the bottle, wine recorking service must be provided.
- Minors are allowed on the premises however are not allowed to purchase, consume or handle beverage alcohol.
