# **General Manager's Message Caroline Cottrell**

In keeping with the past several years at the USSU, 2012-13 witnessed continued change as we sought to fulfill our mandate to serve undergraduate students to the maximum possible. The USSU continues to be a dynamic and responsive organization which keeps the needs of students uppermost in all decision making.

One of the most significant changes this year was the retirement of Freda Salikin after a career with the USSU which began in 1976. We celebrated her long service to students and the USSU at the end of January and we continue to wish her well in her retirement. Freda's departure created some room for substantive changes to the way in which the senior management team was organized and as a result I split responsibilities formerly held by her into

two positions, Facilities Manager and Business and Services Manager, and moved various duties laterally to then create a Communications and Marketing Manager position, where formerly there had been a more limited marketing component. This restructuring left Louis' without a Food and Beverage Manager and so a new manager was hired starting in late December to ensure a smooth transition. These

new configurations have worked exceptionally well and as usual, the senior staff has taken on the challenges with good grace and good humour. Moreover, during an extended medical absence on my part in the fall of 2012, they all willing and cheerfully stepped into the breach and ensured that the organization continued to move smoothly forward.

Throughout the course of 2012, we continued to monitor and manage the USSU's operations despite confronting some particular challenges. Student use of Copy Central continued to decline as new and emerging technologies allowed students to employ divergent mechanisms for acquiring learning materials. We are monitoring the situation very closely and will be presenting a report to University

Students' Council sometime in late fall or over the winter of 2013-14. Interestingly, XL Print and Design continues to thrive and expand under its new manager who took over when our long time designer left to take an animation course in Vancouver. We believe the move from the back of then Browsers, to its own location on the main floor of the MUB has helped re-invigorate the business. As importantly,

moving XL Print and Design was the first step in our long-term plan to wind down Browsers and re-open the space in Upper MUB as another venture.

This new venture, some time in the planning will soon come to into existence, when we open Louis' Loft. Over the past several year it has become clear that university pedagogy has changed and students are now obtaining course materials in new ways, thereby effectively ending the profitability of a used bookstore/coffee shop. Simultaneously it became clear that we needed a second special events space, but one that could function as a coffee and sandwich shop during the day and that we could more easily deal with the needs of campus clubs for social space by having a second,

large area for events. With all these factors in mind, we began the process of redesigning Upper MUB so that it met these needs. It will open at the end of May 2013 and we are very hopeful that it will perform exactly as expected over time. A new space in Upper MUB will, we hope, also offset the loss of Beach Volleyball, closed down when the university required us to hand back the land for the proposed construction of a hotel. Our ability to run a couple of weddings each weekend in the MUB is now assured.

The last operation to note is the Information Centre which continues to be very busy with UPASS. Currently they are getting ready to introduce the first UPASS for spring and summer and although enrolment is significantly less

than during the term, it is still work they have not done in the past. It is, however, very much in keeping with the wishes of undergraduate students to have access to a discounted bus pass throughout the entire year, rather than just in the eight fall and winter months.

Changes to senior management staffing configurations also meant that the USSU's Centres went from being supervised by the Communications Manager to being under the guidance of the Business and Services Manager. The Centres, which include the Pride Centre, the Women's Centre, the Help Centre, the Food Centre and Safewalk/Student Crew, continue to provide valuable services to students, and in many instances, also provide students with a safe and welcoming place to meet like minded individuals. The Centres are all very proactive in mounting events, individually and in concert

with each other, and such regulars as the Drag Show and Take Back the Night attract significant community involvement.

The USSU remains a vibrant union serving students and the broader university community, with a dedicated staff and a highly involved group of students. I remain very proud and humbled to continue in my role of General Manager of such a diverse and interesting organization.

# **USSU Operations**

# **Browsers Café**

This was a year of transition at Browsers. Coffee sales remained strong with the switch to Museo coffee from Starbucks. Traffic increased as customers continue to flock to the space to take advantage of the natural light, atmosphere, and access to the Louis' menu.

The textbook side of the business continued to decline as students found affordable options online and professors move away from traditional textbooks. Serious discussions took place during the year over the future of textbook sales at Browsers and it was decided by year's end that books would need to be removed to make space for increased seating.

Major renovations were planned beginning in the upcoming year. The textbook portion of the operation will cease given the continuing decline in sales. More seating will be added to the venue along with a new service counter that will better serve customers. The menu will be expanded to include sandwiches, salads, baking, and other items that are made inhouse.

The room will be capable hosting special events for student groups and others since Louis' cannot keep up with current demand for space. Having a second room in which to book functions will allow food and beverage revenues to grow in the coming years, thereby ensuring stability for the USSU.

# **XL Print & Design**

XL Print & Design enjoyed continued success due to positive word of mouth and a more welcoming location on the main floor of the Memorial Union Building. Revenues continued to grow and the outlook for XL is strong as the business continues to provide a valuable service that also turns a profit for the USSU.

XL Print & Design specializes in wide format printing, colour copying and graphic design. XL offers wide format colour printing of up to 5 feet and carries various types of media such as matte paper, photo gloss, vinyl, canvas and sticker paper. XL can also print black and white wide format of up to 3 feet for the budget conscious, and can provide design for event posters, invitations, business cards, research posters and, many other products.

# Louis'

2012-13 was a very successful year for Louis' with over \$1.6 million in sales from May to April. The year began with renovations that opened up the space and made the venue more flexible to accommodate various types of events. In addition to structural changes new lighting, flooring, tables, and chairs were added to create a more welcoming atmosphere. The renovations were completed in late May in time for the sold out wedding season.

A sold out Beach Volleyball league meant record revenues for both league fees and food and beverage revenue. Unfortunately this will be the last summer for Louis' Beach Volleyball since the University is repurposing the land for construction of a new hotel.

The fall was highlighted by record attendance in the Bowl and busy Welcome Week concerts. Louis' continued the busy year by catering to students with an extensive menu, nightly promotions, and a wide variety of entertainment.

Louis' continued to grow business outside of the walls of the Memorial Union Building as well. Catering orders came in from across campus including many functions in the newly renovated Place Riel Student Centre. Louis' also continued to provide food and beverage services at Griffith Stadium for events ranging from Huskie Football games to track and field meets.

# **Information Centre**

The Information Centre had continued success in its central location on the main floor of the Place Riel Student Centre. In co-operation with USSU reception they are truly the front door to the U of S campus. Together they satisfy students' needs for U-Pass stickers or opt-outs, housing advertising, CHEP good food boxes, club insurance, show tickets, STC bus tickets, and countless directions to other parts of campus.

# **Copy Central**

Copy Central, the USSU's fleet of photocopiers, continues to be an important service to students despite declining usage. While usage and revenues are down, the service remains valuable to students who need access to the fleet of copiers across campus to do copying of materials. The USSU considers Copy Central a very important service to undergraduates and so USC and the Executive remain willing to support this venture with the funds necessary for the operation to succeed.

# **USSU Student Fee Details**

Students' Union

The Student' Union fee is used to fund advocacy work and services.

Health and Dental Plan

The USSU Health & Dental Plan provides a comprehensive package of health, dental, vision and travel benefits to fill the gaps left by provincial Medicare and a parent or spouse's plan.

# Student Infrastructure Fee

In March 2003 students voted to implement the Student Infrastructure Fee for the purpose of constructing and sustaining student buildings. Primarily this fee will repay the loan acquired for a 22 million dollar renovation and expansion of Place Riel Student Centre.

## U-PASS

Undergraduate students (some exemptions apply) are assessed a mandatory fee of \$74.62 per academic term providing transit coverage from September though December for Term 1, and January through April for Term 2. U-PASS does not include the summer period of May through August. U-PASS allows students unfettered access to Saskatoon Transit services and it is a significant part of the USSU's commitment to sustainability.
