# 4.1 Proposed Amendment to Article 5 – (Proposed Amendment #1, by Benjamin David)

Move to amend Bylaw 1, Article 5, 5.03 Members (ii) to read, "A quorum for any meeting of members shall be at least fifty (50) members. Of these members present, at least fifteen (15) members must be members of the University Students' Council."

# 6.1 Proposed Amendment to Article 10 – (Proposed Amendment #1, by USSU Executive)

Move to amend The Constitution, Article 10 to read "There shall be an annual general meeting of members of the of the University of Saskatchewan Students' Union held between the first day of the winter term and the thirty-first day of January in each academic year. Members shall receive at least fifteen days notice of the Annual General Meeting."

President Gardiner stated that this would change things a little bit. It would mean that the audited financial statements would not be presented until after Christmas. Many of the Executive duties do not begin until September. The Executive need time to work to the best of their portfolios. This may also increase voter turnout and students would have longer in the year to come up with amendments.

Adam Watt asked if the first day of the winter term is the first day of classes and how the fifteen days notice would be given to councilors.

Chair Thoma stated that the AGM could be held on January 31<sup>st</sup> and notice would need to be given on or by January 16<sup>th</sup>.

President Gardiner stated there is no notice in the Constitution for events put on by the Students' Union.
